During the public comment period, Jerry Tinz, who has lived on the Chappel Road for 50 years complained that the road had been oiled and stoned in the past and this year was covered in dirt. He stated the high traffic volume had caused his home to be covered in fine clay dust and that it was affecting his wife's health. He requested that the town highway superintendent remove the clay overburden as salt treatments only last about two weeks.

Daryl Emig, also from Chappel Road, wanted to know the right of way of the town on the roads because there are several trees that are dead or dying and he is afraid they will fall on his buildings.

Duane Miles wondered what was wrong with the boom mower since the sides of the road had not been mowed.
