Marilyn Prutsman from the New York Citizens Audit presented information to the board regarding voter fraud in New York State. She asked the board to put forth a resolution in support of an Audit of the New York State 2022 General Election.

The Supervisor felt that a vote on the resolution should wait until another board meeting when all of the board members are present.

William Reagan asked whether voters in NYC could vote with just a license.

During public comment, Ed Windnagle asked if the 1 year probationary period was for Nate McChesney. Russell said no it was for Mike Potter and that Nathan had been hired as a utility

worker. Ed let the board know that other towns participating in shared services with the Town of Rathbone may not continue if our workers are not present working while the other towns that are helping are. He also feels that buildings are going up in the Town that should be considered commercial for assessment and taxing purposes.

Marge Smith wondered if anyone was going to pressure wash the stairwell before the Old Home Days event. She offered to. Russell said that Scott Clark was going to do that. She also asked if there was a quorum. William Reagan explained that three board members were present and that represented a quorum. That Russell is a board member, and he has no more power than any other board member.

Mickey McConnell asked if we had advertised for an assessor. We have advertised with the New York State and County Assessor Associations.

William Reagan said that the town may a problem soon because we may be running out of gravel in our pit.

Mickey McConnell said that road repairs should be done based on the amount of usage a road gets.

Vicki Warner asked if we could have a Facebook page.

Eric Bump said that he feels the Town of Tuscarora trucks go through the town over the speed limit and drive dangerously coming out of the pit and in the hamlet. Russell said he would contact them let them know we have received complaints and ask them to slow down.

Duane Miles asked who dumped the stone in front of the highway building especially since there will be a food bank tomorrow. Nate said that they ran out of room out back.

Eric Bump asked Nathan what roads the stone was going on, since the Highway Superintendent was not present. He was unsure.

Jill Risley asked if the 284 included the remainder of the Risley Road. Russell was going to look.

William Reagan motioned that we adjourn at 6:55pm seconded by Lanny Newell.
